2010 District Populations

The County of Ventura last redistricted in 2011 with a supervisorial-based process. The populations of each district at that time were based on the 2010 Decennial Census. The total plan deviation was well within the traditional 10% allowed in municipal redistricting.¹

As the following table shows, utilizing the American Community Survey (ACS) data from the 2006-2010 vintage which would be used in the 2011 redistricting, District 5 was only district that had 50% or more of any single Citizen Voting Age Population (CVAP) ethnic/racial subset with a Latino CVAP of 52.6%.

Population Growth and Estimated Deviations

The Statewide Database has released reallocated state prison population, the final dataset that Cities and Counties must use to comply with the Fair Maps Act. This population identifies the whole count of persons and where they resided as of April 1, 2020 with the state prisoner reallocation per state law. Redistricting Partners has concluded the work of placing this data into the census blocks, block groups, and tracts.

¹ These counts are based on the 2010 data put into the 2020 Census geography. There may be slight differences as many census blocks were consolidated that would cause slight differences with the counts at the time of the 2011 redistricting.

When comparing the final 2020 Census Data and the 2010 Census Data, Ventura County has increased in population by 22,068 residents, a growth rate of 2.7%. District 1 saw the largest gain of population with 10,758 new residents, or 6.7% growth, and District 5 was the only district to see a decrease in population, losing 1,737 residents over the past 10 years.

With a final population of 845,389, the ideal population for any district would be 169,078. The seat with the largest population is District 3 at 174,969 (+3.5%) and the smallest is District 2 at 163,289 (-3.4%), placing the county at a total of 6.9% deviation, within the 10% deviation range maximum.

Data on the ethnic and racial subgroups utilized for Voting Rights Act calculations, have been finalized for the current redistricting cycle. This shows the composition of districts based on the racial makeup of eligible voters – those who are citizens and over the age of 18. The CVAP growth rate was 11.7%, higher than the county's growth of 2.5%.

The Latino CVAP figures grew in all five districts, with district 5 reaching nearly 60% Latino CVAP, and the adjacent District 3 reaching more than 40% CVAP. This may become something that the county will want to pay attention to within the redistricting process as there may be

construction of future lines that could be seen as better at making districts that would be effective for protected minority voters.
