Calculating the Tax

Once you enter the unit required for your business type (i.e. in this case, Gross Receipts-as reported to the IRS), click the calculate button. The tax due will calculate for you and include all necessary fees and/or penalties. Be sure to use numbers only rounded to the nearest whole dollar.


