

NOTICE OF PUBLIC AUCTION ON FEBRUARY 16, 2018
OF TAX DEFAULTED PROPERTY FOR DELINQUENT TAXES
 Made pursuant to Section 3702, Revenue and Taxation Code

On November 7, 2017, I, Steven Hintz, Ventura County Tax Collector, was directed to conduct a public auction sale by the Board of Supervisors of Ventura County, California. The tax-defaulted properties listed below are subject to the tax collector's power of sale and have been approved for sale by a resolution dated November 7, 2017 of the Ventura County board of supervisors.

The sale will be conducted at 9:00 a.m., on Friday, February 16, 2018, in the Administration building, Board of Supervisor's Hearing Room, 800 S. Victoria Avenue, Ventura, California as a public auction to the highest bidder for cash in lawful money of the United States or negotiable paper, for not less than the minimum bid as shown on this notice. If no bids are received on a parcel, it may be reoffered at the end of the auction at a minimum price appropriate to stimulate competitive bidding. Any parcel not sold at this scheduled tax sale may be re-offered for sale within a 90-day period.

Due diligence research is incumbent on the bidder as all properties are sold as is. The winning bidder is legally obligated to purchase the property. Transfer taxes will be added to and collected with the purchase price.

The right of redemption will cease Thursday, February 15, 2018, at the close of business and properties not redeemed will be offered for sale. If a parcel is not sold, the right of redemption will revive and continue up to the close of business of the last business day prior to the next scheduled sale.

If the properties are sold, parties of interest, as defined in California Revenue and Taxation Code Section 4675, have a right to file a claim with the county for any excess proceeds from the sale. Excess proceeds are the amount of the highest bid in excess of the liens and costs of the sale. Notice will be given to parties of interest, pursuant to law, if excess proceeds of \$150 or greater result from the sale.
